#### 4.1 Description of first aid measures

#### **General advice**

No known delayed effects. Consult a physician for all exposures except for minor instances.

#### Following inhalation

Move source of dust or move person to fresh air. Obtain medical attention immediately.

Carefully and gently brush the contaminated body surfaces in order to remove all traces of product. Wash affected area immediately with plenty of water. Remove contaminated

#### 7. HANDLING AND STORAGE

#### 7.1 Precautions for safe handling

#### 7.1.1 Protective measures

Avoid contact with skin and eyes. Wear protective equipment (refer to section 8 of this safety data sheet). Do not wear contact lenses when handling this product. It is also advisable to have individual pocket eyewash. Keep dust levels to a minimum. Minimize dust generation. Enclose dust sources, use exhaust ventilation (dust collector at handling points). Handling systems should preferably be enclosed. When handling bags usual precautions should be paid to the risks outlined in the Council Directive 90/269/EEC.

#### 7.1.2 Advice on general occupational hygiene

Avoid inhalation or ingestion and contact with skin and eyes. General occupational hygiene measures are required to ensure safe handling of the substance. These measures involve good personal and housekeeping practices (i.e. regular cleaning with suitable cleaning devices), no drinking, eating and smoking at the workplace. #### 8.2 Exposure controls

To control potential exposures, generation of dust should be avoided. Further, appropriate protective equipment is recommended. Eye protection equipment (e.g. goggles or visors) must be worn, unless potential contact with the eye can be excluded by the nature and type of application (i.e. closed process). Additionally, face protection, protective clothing and safety shoes are required to be worn as appropriate.

#### 8.2.1 Appropriate engineering controls

If user operations generate dust, use process enclosures, local exhaust ventilation, or other engineering controls to keep airborne dust levels below recommended exposure limits.

The use of protective gloves (nitrile), protective standard working clothes fully covering skin, full length trousers, long sleeved overalls, with close fittings at openings and shoes resistant to caustics and avoiding dust penetration are required to be worn.

#### 8.2.2.3 Respiratory protection

Calcium oxide reacts exothermically with water to form Calcium dihydroxide.

#### **10.2 Chemical stability**

Under normal conditions of use and storage (dry conditions), calcium oxide is stable.

#### 10.3 Possibility of hazardous reactions

Calcium oxide reacts exothermically with acids to form calcium salts.

#### 10.4 Conditions to avoid

Minimise exposure to air and moisture to avoid degradation.

#### **10.5** Incompatible materials

Calcium oxide reacts exothermically with water to form calcium dihydroxide:  $CaO + H_2O \rightarrow Ca(OH)_2 + 1155 \text{ kJ/kg CaO}$


